The annual training fee (ATF) must be paid by all ANZCA trainees in approved training, whether full-time or part-time. ATFs are due by:

- January 31 for Australia and New Zealand.
- June 30 for Hong Kong, Singapore and Malaysia.

Applicants and trainees who do not pay the required annual fee by March 31 (Australia and New Zealand) or August 31 (Hong Kong, Singapore and Malaysia) will be withdrawn from the training program. If it is impossible for you to pay the annual training fee within the timeframe required, you may apply to the director of professional affairs assessor for special consideration via assessor-requests@anzca.edu.au. The form is available [here](#) for trainees in Australia and New Zealand and [here](#) for trainees in Hong Kong, Singapore and Malaysia.

If you are interrupting training or wish to train part-time, you will need to apply prospectively. If you are eligible for a reduced fee, the amount will be calculated once your application is approved.
