

# CP25 Policy on endorsement and support of externally developed guidelines 2025

# Short title: External guideline endorsement

# 1. Purpose

To identify documents which have been developed and published by organisations external to ANZCA that align with ANZCA's purpose, have benefit to the community, and contribute to the practice of anaesthesia, pain and/or perioperative medicine. These documents may include guidelines, practice recommendations or polices. ANZCA representatives may have contributed to the development of these documents. Such documents, meeting criteria designated in this policy, may be considered for endorsement or 'support' by ANZCA council.

# 2. Scope

This policy applies to documents which have been developed and published by organisations or societies external to ANZCA. It does not apply to ANZCA Professional Documents or other documents developed internally by ANZCA.

# 3. Considerations

- 3.1 The Australian and New Zealand College of Anaesthetists (ANZCA), which includes the Faculty of Pain Medicine, strives to serve the community by fostering safety and high quality patient care in anaesthesia, perioperative medicine and pain medicine. ANZCA Council may endorse externally developed guidelines deemed to contribute to efforts in this regard.
- 3.2 The Faculty of Pain Medicine may also endorse relevant externally developed guidelines according to its own criteria.
- 3.3 Endorsement of an external guideline by ANZCA indicates that it has passed a review process as outlined in CP25 and has been approved by ANZCA council for endorsement. Endorsement means that the external document aligns with ANZCA's purpose, has benefit to the community and contributes to the practice of anaesthesia, pain and perioperative medicine. The endorsement of external guidelines or documents is to recognise their value as noted above and provide a ready resource for access via the ANZCA website.
- 3.4 Endorsed external documents should not contain material that contradicts existing ANZCA Professional Documents, Standards or other policy including training policy. Should an endorsed external document contain within it statements that might be interpreted as contradicting ANZCA documents (Professional Documents (guidelines, policies), standards etc) then the existing ANZCA document(s) take precedence.
- 3.5 An endorsed document, or the website on which it is located, may note that "This document is endorsed by the Australian and New Zealand College of Anaesthetists (ANZCA)".
- 3.6 From time to time an external organisation requests that ANZCA 'co-badge' an endorsed document (ie allow the ANZCA crest to be displayed on the document). If endorsed, the request for co-badging will be considered by council noting that the co-badging, like the endorsement, only applies to the current version of the document.

3.7 A guideline assessment tool (see appendix 1) has been created to articulate ANZCA's approach to endorsing externally developed guidelines and clarify the college's expectations in this regard. The tool also supports standardised decision-making in relation to endorsement of externally developed guidelines. The tool is complemented by explanatory notes in *CP25BP Policy on endorsement of externally developed guidelines Background Paper*.

### 4. Process of endorsement

ANZCA

- 4.1 A request from within the ANZCA community or an external body will trigger the endorsement process.
- 4.2 The request will be directed to the Safety and Quality team for preliminary consideration and referral to a committee of ANZCA Council, as relevant.
- 4.3 If supportive of the request, the committee will identify a content expert to undertake a formal assessment using the guideline assessment tool. The decision to formally assess a guideline for endorsement in no way indicates a commitment from ANZCA to endorsement.
- 4.4 Informed by the formal assessment (that is, the guideline assessment tool completed by the nominated expert), a recommendation (endorsement or otherwise) will be made to ANZCA Council (via the relevant committee, if applicable).
- 4.5 ANZCA Council's decision will be relayed to the Safety and Quality team and the relevant committee support officer.
- 4.6 In liaison with the Safety and Quality team, the committee support officer will advise the requester of the outcome of ANZCA Council's deliberations.
- 4.7 If the externally developed guideline is endorsed by ANZCA, the Safety and Quality team will create a listing within the ANZCA endorsed guidelines webpage. The listing will include the date of the guideline's endorsement.
- 4.8 The Communications Unit may be engaged to assist with communicating the endorsement to ANZCA Fellows, trainees, international medical graduate specialists and the wider community.
- 4.9 Any endorsement granted is limited to the version of the guideline reviewed by ANZCA. Should a revised version be published, the listing referred to in item 4.7 may be removed from the endorsed guidelines webpage at ANZCA's discretion. The revised version will be subject to re-evaluation before endorsement can be considered.
- 4.10 When ANZCA has been requested to endorse a document still in draft form, endorsement will be provisional until the final version is published. The final version will be listed on the ANZCA endorsed guidelines webpage after it has been checked by the Safety and Quality team (or evaluated by relevant expert as necessary) and approved by the Chair of the relevant committee.
- 4.11 In certain circumstances, ANZCA may find that a document that provides some content of value and has been through a review using the CP25 Assessment Tool, none the less contains some content that is at variance with ANZCA existing documents, policies or principles. In these circumstances, consideration may be given to a designation by council of 'Support' for the document.
  - 4.11.1 Should ANZCA Council choose to "support" an external document, then the document, or the website on which it is located, may note that "This document is supported by the Australian and New Zealand College of Anaesthetists (ANZCA), with conditions as noted on the ANZCA website."



- 4.11.2 The supported document will be listed on the ANZCA website with a qualifying statement specifying what aspect(s) of the document are not supported by ANZCA. The wording of this statement will be provided by council or delegated to a committee or the Professional Documents unit.
- 4.11.3 Sections 4.8 4.9 also apply to an "ANZCA Supported" Document.

#### 5. Revocation of endorsement

5.1 The College may revoke endorsement or support of a document at any time.

This document is accompanied by a background paper (CP25BP) which provides more detailed information regarding the rationale and interpretation of the Policy.

#### **Related ANZCA documents**

CP24 Policy for the development and review of professional documents

Professional documents of the Australian and New Zealand College of Anaesthetists (ANZCA) are intended to apply wherever anaesthesia is administered and perioperative medicine practised within Australia and New Zealand. It is the responsibility of each practitioner to have express regard to the particular circumstances of each case, and the application of these ANZCA documents in each case. It is recognised that there may be exceptional situations (for example, some emergencies) in which the interests of patients override the requirement for compliance with some or all of these ANZCA documents. Each document is prepared in the context of the entire body of the college's professional documents, and should be interpreted in this way.

ANZCA professional documents are reviewed from time to time, and it is the responsibility of each practitioner to ensure that he or she has obtained the current version which is available from the college website (www.anzca.edu.au). The professional documents have been prepared having regard to the information available at the time of their preparation, and practitioners should therefore take into account any information that may have been published or has become available subsequently.

While ANZCA endeavours to ensure that its professional documents are as current as possible at the time of their preparation, it takes no responsibility for matters arising from changed circumstances or information or material which may have become available subsequently.
